

We haven't seen the level of brazen mendacity in this case in any other case. Remember, Jodi was on the stand for an unprecedented 18 days. We haven't seen the level of fabricating evidence and fakery in any other case. We haven't seen an orgy of evidence (photos, letters, blood, audio recordings) to this extent in any other case. And perhaps more pertinent than anything else, we haven't seen a chameleon of Jodi Arias' calibre in any other case. Once again the authors leave no stone unturned in providing links to all their research, to give the reader unfettered access to all the latest news, video, commentary, memes and more. To recap, AUDACITY, book 1 (and #2 Bestseller for several days), deals with the original trial of the infamous murderess, Jodi Arias.

MENDACITY, book 2, is a follow-up focusing on the Penalty Phase (after a second hung jury). AUTHENTICITY, book 3, focuses on those documents released after the penalty phase, including Jodi's ridiculous 36 page manifesto, the complete Gmail chat (in chronological order) which played a critical role in

the run-up to the murder. AUTHENTICITY also presents a thorough analysis of the shocking and at times touching statements and testimonies from the Sentencing hearing on April 13th 2015, when Jodi was finally sentenced to life behind bars without parole.

The authors also provide links to every sound byte from April 13th, and discuss the implications these have on the case retrospectively.

In AUTHENTICITY the authors probe not just the legitimacy of the legal process via a California-based law professional, but also the genuineness of some of the legal practitioners. Besides that they interrogate the genuineness - the absolute lack of - from Jodi herself. Is she a psychopath? Why is the Law of Attraction so dangerous as it was in this case?
